Biographical Information/ Historical Information:

Thomas Hough (1825-1910) was born in New York City. He spent his childhood of a farm in Manchester, New Jersey. At age 15, he started working at Rogers Locomotive and Machine Works in Paterson, before leaving their employment to learn cabinetry. He worked in several locations, but spent 25 years working in a piano case factory in New York City. He married Mary E. Taylor of Paterson in 1858. The couple had six children together. Mary pre-deceased Thomas, as did four of their children. Hough died on March 27, 1910 at the age of 85. At the time of his passing, he lived at 152 Hamilton Avenue. In 1892 the newspaper indicates that Thomas purchased a property on the corner of Godwin Street and Graham Avenue. It is unclear how many properties he may have owned in Paterson throughout his lifetime.

According to a newspaper article from 1886, the music firm of Thomas Hough & Son first started in 1864 and was locate on West Street. His 1910 obituary indicates that the firm opened in 1872. The company moved to 36 Main Street in 1879. According to several newspaper ads, Thomas Hough & Son sold pianos, organs and musical items. They offered tuning and repairs. The store also advertised cards, stationary, toys, novelties and fancy goods. In 1902, Thomas retired from the business. His son Nathaniel Taylor Hough continued to operate it alone. An ad in 1903 indicates a retirement sale and specifically mentions stationary and toys. However, Hough's 1910 obituary indicates that his son is still operating the piano business at that time.

Archival History:

This collection was transferred to the Paterson Museum in June of 1993 from the Dey Mansion/Washington's Headquarters Museum. The transfer records do not indicate why or how the documents first came into the collection of the Dey Mansion, however there may be some relationship with the Van Boskirk Collection, which is still held at the Dey Mansion at the time of this writing. During the drafting of this aid, Museum staff inquired with the Department of Cultural and Historic Affairs at the County of Passaic, but no additional information was uncovered.

Due to the transfer, call items have two accession numbers. The first, which begins with an X, is the number applied to it by the Dey Mansion. The second accession number, beginning 1993.38 was given to the collection when it entered the Paterson Museum collection in 1993.
